**4. Motion to Approve August 27, 2020 Minutes:** Motion to Approve the August 27, 2020 Minutes was made by Member Djukic and seconded by Member Burson. Ayes were 6, nays were 0. Motion carried unanimously.

**5. Discussion Items:**

**a. Restaurant Bingo:**

- i. Chief Millar reported that one bingo card had been turned in for a Village Gift Card.
- ii. Commission would like to create other opportunities for our community to support local businesses during this difficult time.

**b. Holiday in the Hills – December 5, 2020:**

- i. Commission discussed alternative options given current COVID concerns.
- ii. Commission recommends that we cancel Holiday in the Hills as it has been conducted in the past but recommends alternative ways to celebrate the season.
- iii. Virtual Giving Tree: Miss Gregory indicated that the new Village website could host a Virtual Giving Tree.
  1. Families in need could privately share their needs.
  2. Families who would like to give would likewise complete an online form.

3. Both forms would be fillable on the website – those families in need and those families that want to give would then be matched to one another.
  4. Forms would be available on the website by November 7.
  5. The due date for the gifts is December 12.
  6. Gifts will be available by December 19. Delivery or pick up details to come.
- iv. Tree Lighting: We will light the Village Trees on Saturday, November 28 at 6:00 PM.
    1. Hoping that many in our community would light their trees on that same date and time.
    2. Need to share this information with our community.
  - v. Trustee White Eagle along with Members Wright, Carrell, and Mohr will reach out to local businesses to have them join in the decorating and lighting trees by their businesses on November 28. We can also follow up with an email to the businesses.
- c. **Winter Wonders:**
- i. Will consider alternative dates depending on availability of the Village Hall and Huskies.
  - ii. Discussion regarding Winter Wonders is tabled until future meetings.
- d. **Parameters for Citizen of the Year:**
- i. Commission discussed changing the date for recognizing the Citizen of the Year.
  - ii. Anticipate that the winner will be announced Spring of 2021.
  - iii. Further discussion was tabled.
- e. **Welcome Committee:**
- i. The new Village website is a perfect tool for those new to our community.
  - ii. Commission discussed alternative ways of reaching new home purchasers, including reaching out to realtors.
  - iii. Member Djukic will create a subcommittee to discuss Welcome Committee and the best way to proceed.
