This work includes the field and office time necessary to perform a routine bridge inspection of the Denker Road bridge over Ferson Creek, located 0.7 miles north of Bolcum Road. HR Green will review prior inspection reports, visit the site, complete an inspection utilizing an IDOT certified Program Manager and submit IDOT routine inspection forms to IDOT on behalf of the client.

HR Green will provide copies of these forms along with a letter report for the Denker Road bridge summarizing our recommendations and upcoming maintenance issues the client may need to include in their next budget cycle (or sooner if appropriate).

The professional services included under this contract are intended to fulfill the requirements of a Biennial Bridge Safety Inspection as defined by the Illinois Department of Transportation Structure Information and Procedure Manual. The condition of the items included in the Illinois Structures Information System will be reported according to the Procedure manual. The above services exclude review of the original design, construction and any comparison of the design and construction to current standards.

TERMS AND CONDITIONS


