

**AN ORDINANCE OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS
CORRECTING A SCRIVENER'S ERROR IN ORDINANCE NUMBERING**

WHEREAS, the Village of Campton Hills, Kane County, Illinois (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Village President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois (the "*Corporate Authorities*") may from time to time amend Village Ordinances when it is determined to be necessary, desirable and in the best interests of the health, safety and welfare of the Village and its residents; and

WHEREAS, the Village passed six (6) Ordinances in 2021, and assigned only three (3) Ordinance Numbers to these six (6) Ordinances, due to a Scrivener's Error; and

WHEREAS, the Village President and Board of Trustees of the Village of Campton Hills (the "*Corporate Authorities*") find that correcting this Error by renumbering three (3) of these Ordinances is necessary, desirable and in the best interests of the health, safety and welfare of the Village and its residents.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. That the following Ordinances are hereby renumbered:

The Ordinance entitled “*AN ORDINANCE AUTHORIZING THE DISPOSAL OF SURPLUS PROPERTY IN POSSESSION OF THE VILLAGE OF CAMPTON HILLS,*” passed by the Village Board on August 17, 2021, is hereby assigned the new Ordinance Number O-21-08A. The Village Clerk is hereby directed to renumber this Ordinance to reflect this change.

The Ordinance entitled “*AN ORDINANCE PERTAINING TO THE CORONAVIRUS LOCAL FISCAL RECOVERY FUND FOR THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS,*” passed by the Village Board on June 1, 2021, is hereby assigned the new Ordinance Number O-21-09A. The Village Clerk is hereby directed to renumber this Ordinance to reflect this change.

The Ordinance entitled “*AN ORDINANCE OF THE VILLAGE CODE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS ESTABLISHING A NEW SPEED LIMIT ON OLD BURLINGTON ROAD WITHIN THE VILLAGE.,*” passed by the Village Board on June 1, 2021, is hereby assigned the new Ordinance Number O-21-10A. The Village Clerk is hereby directed to renumber this Ordinance to reflect this change.

Section 3. That these Ordinances are hereby re-adopted and approved by the Village Board verbatim, and only the Ordinance Numbers is changed hereby.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.


Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect upon its passage, approval, and publication in the manner provided by law.
