ORDINANCE
(Adoption of Certain Ordinances by Reference)

WHEREAS, the Village of Campton Hills was incorporated by judicial order on May 14, 2007; and

WHEREAS, the judge who incorporated the Village, the Honorable Michael J. Colwell, entered an order on May 14, 2007 maintaining, in effect, pending further Village action, certain county ordinances, codes, rules and regulations of the County of Kane.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, that:

Section 1: It is in the best interest of the Village of Campton Hills and its citizens that the following Ordinance of the County of Kane be adopted by reference, as if fully set forth herein, as and for the respective ordinances of the Village of Campton Hills, and the same are hereby adopted:


- A. Kane County Subdivision Ordinance

- C. Kane County Animal Control Ordinance
