

**VILLAGE OF CAMPTON HILLS  
AN ORDINANCE AMENDING THE VILLAGE OF CAMPTON HILLS CODE BY  
ADDING A NEW TITLE 7, ANIMAL CONTROL**

WHEREAS, the Village of Campton Hills adopted the Kane County Animal Control Ordinance pursuant to Ordinance No. O-07-02; and

WHEREAS, the Village of Campton Hills entered into an Interim Agreement for Animal Control Services with Kane County; and

WHEREAS, the Village of Campton Hills will find it necessary at times to use the Village Police Department and other departments for animal control services when Kane County Animal Control is unavailable; and

WHEREAS, the Village should be equitably reimbursed for its expense in providing animal control services:

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

**Section 1.** There is hereby added to the Village Code of the Village of Campton Hills a new Title 8 entitled "Animal Control" as follows:

**TITLE 8**  
**ANIMAL CONTROL**

**8-1-1 KANE COUNTY ANIMAL CONTROL ORDINANCE ADOPTED:**

The provisions of the Kane County Animal Control Ordinance are hereby adopted by reference as part of this Title 8.

**8-1-2 INTERIM AGREEMENT FOR ANIMAL CONTROL SERVICES WITH KANE COUNTY**

The Intergovernmental Agreement made and entered into on May 29, 2007 between the County of Kane and the Village of Campton Hills provides for various fees for animal control services performed by the County of Kane. These fees are hereby adopted by reference as part of this Title 8 and to the extent paid to the County by the Village, will be charged to the owner or person in possession of the animal.

**8-1-3 ANIMAL CONTROL SERVICES PERFORMED BY THE VILLAGE OF CAMPTON HILLS.**

In the event that the Kane County Animal Control Service is unavailable and the Village of Campton Hills Police Department or other Village Departments must perform the following animal control services, the Village will impose the following fees to the individual owner of the animal, in addition to any expenses paid by the Village to others on behalf of such animal:

Pick up stray or sick or injured animal \$75.00

**Section 2.** This Ordinance shall be in full force and effect from and after the date of its passage, approval and publication as required by law. This Ordinance shall be published in pamphlet form.
