

**VILLAGE OF CAMPTON HILLS  
AN ORDINANCE AMENDING THE VILLAGE CODE OF THE VILLAGE OF  
CAMPTON HILLS, CHAPTER 8 OF TITLE 1 BY ADDING SECTION 1-8-7**

BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

**Section 1.** Chapter 8 of Title 1 of the Village Code is hereby amended to add Section 1-8-7 as follows:

**“1-8-7 REIMBURSEMENT FOR FURNISHING COPIES OF TRAFFIC ACCIDENT REPORTS AND OTHER POLICE RELATED REPORTS:**

- A. The Village of Campton Hills shall receive a fee of \$5.00 for furnishing a copy of a Traffic Accident Report prepared by the Village or any other police agency.
- B. There shall be a fee of \$20.00 for an Accident Reconstruction Report.
- C. Fingerprinting upon request of a resident of the Village of Campton Hills shall be performed without charge and there shall be a fee of \$25.00 for finger printing requested by a non-resident.

**Section 2.** This Ordinance shall be in full force and effect from and after the date of its passage and approval as required by law. This Ordinance shall be published in pamphlet form.

AN ORDINANCE AMENDING SECTION CHAPTER 7 OF TITLE 1 OF THE VILLAGE  
CODE BY ADDING A NEW SUBSECTION 1-7-12

BE IT ORDAINED by the President and Board of Trustees of the Village of  
Campton Hills, Kane County, Illinois that:

**Section 1.** The Village Code is hereby amended to add a new Section 1-7-12  
to Chapter 7 of Title 1 to provide as follows:

**“1-7-12: OTHER, BENEFITS OFFERED TO EMPLOYEES FROM TIME TO TIME**

In addition to paid vacations provided in accordance with Section 1-7-11 of  
this Code, employees of the Village who work an average of forty (40)  
hours or more per week shall be considered “Full Time Employees” and  
shall be eligible to receive such benefits, if any, offered to full time  
employees.”

**Section 2.** This Ordinance shall be in full force and effect from and after the date  
of its passage and approval as required by law. This Ordinance shall be published in  
pamphlet form.

**VILLAGE CODE OF CAMPTON HILLS  
AMENDMENT TO ARTICLE F OF CHAPTER 7 OF  
TITLE 1 TO ADD NEW SUBSECTION 1-7F-9 TO THE VILLAGE CODE**

BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

**Section 1.** Article F, of Chapter 7 of Title 1, of the Village Code of Campton Hills, is hereby amended to provide a new subsection as follows:

**"1-7-F-9. Holiday Pay for Part Time Police Officers.**


Part Time Police Officers shall be paid one and one-half (1-1/2) times their pay rate when they work on Village Holidays as defined in Section 1-7-11-A1 of this Code.
