

**AN ORDINANCE DISCONNECTING CERTAIN TERRITORY FROM
THE VILLAGE OF CAMPTON HILLS
(THORNTON PROPERTY)**

WHEREAS, the owners of record of 100% of the property described as Parcels 1, 2, 3, 4, 5 and 6 in Exhibit A attached hereto and a part hereof, have filed with the Village of Campton Hills a Petition to Disconnect such property pursuant to 65 ILCS 5/7-3-4; and

WHEREAS, said Petition to Disconnect was filed on March 4, 2008, being more than 30 days prior to the date of adoption of this ordinance; and

WHEREAS, the aforesaid property lies upon the border but presently is within the boundary of the Village of Campton Hills; and

WHEREAS, the Petition for Disconnection was accompanied by a certificate from the Kane County Clerk showing that there are no village taxes or assessments due up to the time of presenting the petition:

NOW, THEREFORE, Be It Ordained by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, that:

Section 1. The Corporate Authorities find that the statements in the preamble of this Ordinance are true and the same are incorporated in this Ordinance by reference as if fully set forth in this section.

Section 2. The territory described as Parcels 1, 2, 3, 4, 5 and 6 in Exhibit A, attached hereto and a part hereof, is hereby disconnected from the Village of Campton Hills effective on January 5, 2009.

Section 3. A copy of this Ordinance, duly certified by the Village Clerk, shall be filed with the Recorder of Kane County within ninety (90) days after its effective date.

Section 4. This Ordinance shall be in full force and effect from and after January 5, 2009. This Ordinance shall be published in pamphlet form.
