

VILLAGE CODE AMENDMENT  
VILLAGE OF CAMPTON HILLS  
AMENDMENT TO SECTION 3-1-5G AND SECTION 3-1-5I,  
ADDING A PROVISION FOR A NEW  
CLASSIFICATION OF LIQUOR LICENSE, "AB &W LICENSE" TO AUTHORIZE  
PACKAGE SALES OF BEER AND WINE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS AS FOLLOWS:

**SECTION 1:** Section 3-1-5G of the Village Code is hereby amended to add thereto the following immediately after the paragraph entitled "Class AP Licenses":

Class AB & W Licenses (Beer and Wine Package Sales): Such licenses shall authorize the retail sale by stores and gasoline stations of beer and wine in the original package on the premises specified in the license for consumption off the premises and shall not authorize the sale of alcoholic liquor for consumption on the premises.

**SECTION 2:** Section 3-1-5 I of the Village Code is hereby amended to add thereto the following to the table set forth in said section immediately after "Class AP":

Class AB & W                      \$2,000.00                      Per year

**SECTION 3:** Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.

**SECTION 4.** This Ordinance shall take full force and effect upon its passage, approval and publication as provided by law. This Ordinance shall be published in pamphlet form.
