

Ordinance No. O-12-11

VILLAGE CODE AMENDMENT
VILLAGE OF CAMPTON HILLS
AMENDMENT TO SECTION 7-2-2B(Parking)
OF THE VILLAGE CODE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1. Section 7-2-2B of the Village Code which now provides:

Parking: To park any vehicle in the front yard, back yard, corner yard, side yard or any additional area of a lot or parcel of land situated between the public right of way and any residence or accessory building or structure located therein, except that parking is permitted in an area duly improved (i.e. a gravel, asphalt or concrete area) for parking purposes and the parking of noncommercial vehicles is permitted in a driveway,

is hereby amended and restated to provide as follows:

Parking:

1) To park any vehicle in the front yard, back yard, corner yard, side yard or any additional area of a lot or parcel of land situated between the public right of way and any residence or accessory building or structure located therein, except that parking is permitted in an area duly improved (i.e. a gravel, asphalt or concrete area) for parking purposes and the parking of noncommercial vehicles is permitted in a driveway.

2) To park any vehicle upon any portion of property owned by any public body (other than the Village of Campton Hills) which has posted "No Parking" signs as to such property or portion thereof.

SECTION 2. This Ordinance shall take full force and effect upon its passage, approval and publication as provided by law. This Ordinance shall be published in pamphlet form.


