

**AN ORDINANCE
ADOPTING AN AMENDED OFFICIAL
COMPREHENSIVE PLAN OF THE
VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS**

WHEREAS, pursuant to Section 11-12-5 et seq. of the Illinois Municipal Code (65 ILCS 5/11-12-5 et seq.), the Village of Campton Hills adopted Ordinance No. O-07-31, adopting an Official Comprehensive Plan and an Official Map affecting all property within the Village of Campton Hills, Kane county, Illinois and the unincorporated territory within one and one-half (1 ½) miles within the Village boundary and thereafter has amended such Plan; and

WHEREAS, after numerous public hearings pursuant to law, work sessions involving members of the public and committees of volunteers, the Plan Commission of this Village has recommended to the Corporate Authorities an Amended Comprehensive Plan to replace the Comprehensive Plan which was adopted by Ordinance No. O-07-31, as amended; and

WHEREAS, the Corporate Authorities have considered the recommendation of the Plan Commission and have considered the draft Ordinance and have considered the proposed Comprehensive Plan and have made certain changes to said draft Plan:

NOW THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. The Official Comprehensive Plan and Official Map of the Village of Campton Hills, Kane County, Illinois is hereby amended and restated as set forth in Exhibit A attached hereto and a part hereof.

SECTION 2. The Village Clerk of the Village of Campton Hills, Kane County, Illinois shall file notice of the adoption of this Ordinance amending the Official Comprehensive Plan and Official Map of this Village with the Recorder of Kane County.

SECTION 3. This Ordinance shall be in full force and effect upon its passage and approval and upon the expiration of ten (10) days after the date of filing notice of the adoption of this Ordinance with the Recorder of Kane County.
