

**VILLAGE CODE AMENDMENT  
VILLAGE OF CAMPTON HILLS  
ADDITION OF CHAPTER 5 TO TITLE 3  
VILLAGE CODE RELATIVE TO DAY CARE HOMES**

Whereas, the State of Illinois provides extensive regulations which provide for the licensing, inspection and other controls as to Day Care Homes; and

Whereas, Day Care Homes are defined in Section 406.2 of Part 406 of Chapter I of Title 89 of the Illinois Administrative Code; and

Whereas, Day Care Homes provide an important public service to the citizens of this Village:

Now Therefore, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS, AS FOLLOWS:

**SECTION 1:**A new chapter 5 is hereby added to Title 3 of the Village Code of this Village as follows:

**Chapter 5.**Day Care Homes

**3-5-1. Day Care Homes Defined.**

Day Care Homes are hereby defined as set forth from time to time in section 406.2 of Chapter I of Part 406 of Title 89 of the Illinois Administrative Code.

**3-5-2. Day Care Homes Conditionally Permitted.**

Day Care Homes duly licensed by the State of Illinois shall be permitted, upon the approval of a permit application filed with the Building and Zoning Officer of the Village and payment of an application fee of \$25.00; provided, however, if the location of such Day Care Home is located on a non-arterial road, the application shall be referred to the Village Zoning Board of Appeals, with reasonable notice given to all property owners whose properties are within 250 feet of the proposed Day Care Home.

**SECTION 2:** Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.

**SECTION 3:** This Ordinance shall take full force and effect upon its passage and approval provided by law. This Ordinance shall be published in pamphlet form.
