

**VILLAGE OF CAMPTON HILLS
AN ORDINANCE AMENDING AND RESTATING
THE VILLAGE CODE OF THE VILLAGE OF CAMPTON HILLS**

WHEREAS, the Village Code of this Village as originally adopted by the Corporate Authorities, has been amended from time to time; and

WHEREAS, it will assist in the administration of the Village and assist all persons utilizing the Village Code to have an Amended and Restated Village Code which incorporates all amendments which have been made to this Village Code to and through February 19, 2013 (thus including Ordinance No. O-13-03):

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS AS FOLLOWS:

Section 1. The Village Code of the Village of Campton Hills and all amendments thereto which have been adopted and which remain in force as of this date, are hereby incorporated within the Amended and Restated Village Code and the Village Code which is attached hereto and incorporated herein is hereby amended and restates as "The Village Code of the Village of Campton Hills," which is hereby declared to be, and shall hereafter constitute, the official Village Code of the Village of Campton Hills as of the effective date of this Ordinance:

Section 2. Nothing in this Ordinance or in the Amended and Restated Village Code which is adopted hereby shall invalidate or affect any action heretofore taken or which is pending pursuant to the Village Code which this Amended and Restated Village Code replaces.


Section 3. Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.

Section 4. This Ordinance shall take full force and effect on the date, which is fourteen (14) days after its publication. This Ordinance shall be published in pamphlet form.
