AN ORDINANCE READOPTING SECTION 6-1-1
OF THE VILLAGE CODE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS THAT:

Section 1. Section 6-1-1 of the Village Code of the Village of Campton Hills entitled "Vehicle Code Adopted", a copy of said Section 6-1-1 being attached hereto, is hereby readopted as of the effective date of this Ordinance, thus clearly including in the Village Code all current sections of the Illinois Vehicle Code referenced in the Village Code Section 6-1-1.

Section 2. This Ordinance shall be in full force and effect upon passage, approval and publication pursuant to law. This Ordinance shall be published in pamphlet form.

**TITLE 6
VEHICLE CODE**

CHAPTER 1

6-1-1 VEHICLE CODE ADOPTED:

Provisions Adopted

- A. Pursuant to the authority granted to municipalities by Section 20-204 of the Illinois Vehicle Code (625 ILCS 5/20-204) there is hereby adopted by reference as part of this Title 6, the following provisions of the Illinois Vehicle Code, 625 Illinois Compiled Statutes, the same being a public record of the state as now in effect, and as may be amended from time to time, subject to deletions, additions, amendments or modifications hereinafter set forth:
1. Chapters 1, 3, 6, 9, 11, 12, 13A, 13B, 15 and 16 in their entirety except 625 Section 11-501(d) (ILCS 5/11-501(d)).
 2. Snowmobile Registration and Safety Act.
 3. Child Passenger Protection Act.
- B. Exclusions: Excluded from adoption by reference and hereby deleted are Chapters 2, 4, 5, 7, 8, 10, 14, 17, 18A, 18B and 18C and the miscellaneous laws of the Illinois Vehicle Code, except as specified above.

6-1-2 AMENDMENTS TO CODE:

The amendments, modifications, and/or additions, as found in the following sections of this title, are hereby made in the provisions in the Illinois Vehicle Code otherwise herein adopted by reference. To the extent such amendments, modifications and/or additions or any other provisions of this Code are inconsistent with the provisions of the Illinois Vehicle Code herein adopted, the more restrictive and specific regulation shall apply.

6-1-3 CITATIONS:

Any citation to the above and foregoing provisions shall be designated as set forth in the Illinois Vehicle Code and prefixed by reference to Title 4 of this Code.
