

VILLAGE CODE AMENDMENT
VILLAGE OF CAMPTON HILLS
AMENDMENT TO SECTIONS 6-1-30 A 5
OF THE VEHICLE CODE

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: Section 6-1-30 A 5 of the Village Code is hereby amended to provide as follows:

6-1-30 PARKING, REGULATIONS

A. Stopping, standing or parking prohibited

5. It shall be unlawful for any person to park a motor vehicle or, if parked, to allow a motor vehicle to remain parked or standing in any public street, roadway, or alley during or after a snowfall in which there is an accumulation of two (2) inches of snow or more. This prohibition shall remain in effect until such time as the street, roadway, or alley has been plowed or the snow has been removed therefrom. A street shall not be deemed to have been plowed until the lane of traffic nearest the curb has been plowed or the snow has been removed therefrom.

SECTION 2: Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.

SECTION 3. This Ordinance shall take full force and effect upon its passage, approval and publication as provided by law. This Ordinance shall be published in pamphlet form.
