

**AN ORDINANCE AMENDING THE VILLAGE OF CAMPTON HILLS
CODE REGARDING FIREWORK OFFENSES**

WHEREAS, the Village of Campton Hills is a non-home rule municipality; and

WHEREAS, the Village desires to adopt by reference in the Village of Campton Hills Code the provisions Pyrotechnic Use Act, 425 ILCS 35/0.01 *et seq.*; and

THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS, AS FOLLOWS:

SECTION 1. The recitals listed above are incorporated into this Ordinance as if fully set forth in this Section 1.

SECTION 2. Section 7-3-1, entitled “Particular Offenses,” of Chapter 3, entitled “Miscellaneous Offenses,” of Title 7, entitled “Animal Control, Nuisances, Property Maintenance and Burning and Miscellaneous Offenses,” of the Village of Campton Hills Code is hereby amended to add a new subsection D, as follows:

7-3-1 PARTICULAR OFFENSES:

It is hereby declared that any of the following activities are unlawful:

A. The possession, use, sale, gifting or other distribution of drug paraphernalia as defined by the Illinois Statutes.

B. The possession, use, sale, gifting or other distribution of cannabis.

C. The violation of the hours of curfew for persons under such age as established by State Statute.

D. The violation of the Pyrotechnic Use Act, 425 ILCS 35/0.01 et seq., including the possession, sale, and use of fireworks in the Village, except as expressly authorized by the Village Board for a community event.

SECTION 3. All Ordinances in conflict with this Ordinance are hereby repealed to the extent of the conflict.

SECTION 4. This Ordinance shall be in full force and effect from after its passage, approval, and publication in the manner provided by law.
