VILLAGE OF CAMPTON HILLS  
AMENDMENT TO SECTION 1-7-11 A  
HOLIDAYS AND VACATIONS

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS AS FOLLOWS:

**SECTION 1:** Section 1-7-11 A of the Village Code which now provides:

**1-7-11: HOLIDAYS AND VACATIONS:**

**A. Holidays:**

1. Except as may be otherwise provided, the following holiday schedule shall be observed by the Village office:

New Year's Day	January 1
Martin Luther King Day	January (third Monday)
President' Day	February (third Monday)
Memorial Day	May (fourth Monday)
Independence Day	July 4
Labor Day	September (first Monday)
Columbus Day	October (second Monday)
Veteran's Day	November 11
Thanksgiving Day	November (fourth Thursday)
Christmas Day	December 25

Is hereby amended and restated as follows:

**A. Holidays:**

1. Except as may be otherwise provided, the following holiday schedule shall be observed by the Village office:

New Year's Day	January 1
Martin Luther King Day	January (third Monday)
President' Day	February (third Monday)
Memorial Day	May (fourth Monday)
Independence Day	July 4
Labor Day	September (first Monday)
Columbus Day	October (second Monday)
Veteran's Day	November 11
Thanksgiving Day	November (fourth Thursday) and Friday that follows

Christmas Day

December 25

**SECTION 2:** Any motion, order, resolution or ordinance in conflict with the provisions of this Ordinance is, to the extent of such conflict, hereby superseded and waived.

**SECTION 3.** This Ordinance shall take full force and effect upon its passage and approval as provided by law. This Ordinance shall be published in pamphlet form.
