BURNING TREE DRAINAGE IMPROVEMENTS
(May 1, 2017 - April 30, 2018)

BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

SECTION 1: A tax of the following sum of money or as much thereof as may be authorized by law to defray the expenses and liabilities of the Village related to Village of Campton Hills Special Service Area No. 3, be and the same is hereby levied for the purposes specified against the taxable properties described in Exhibit A attached hereto for Engineering Design, Construction Engineering, Easements, Legal Expenses, Construction Expense, Interest Expense and all other expenses for or related to Special Service Area No. 3 \$1,020.01

Total Special Service Area Number Three Levy \$1,020.01

SECTION 2: This Ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law. This Ordinance shall be published in pamphlet form.




