

**AN ORDINANCE
AMENDING SECTION 2-5-1 OF THE VILLAGE CODE
REGARDING COMMUNITY RELATIONS COMMITTEE**

WHEREAS, the Village Board created an Ad Hoc Committee to review the Village's committees and commissions; and

WHEREAS, following a thorough review, the Village President and Board of Trustees desire to amend Section 2-5-1 of the Campton Hills Village Code pertaining to the community relations committee.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. The above recitals are incorporated into this Ordinance by reference.

Section 2. Chapter 5, entitled Community Relations Committee, of Title 2, entitled "Boards, Commissions, and Committees," of the Campton Hills Village is hereby amended as follows:

**"Chapter 5
COMMUNITY RELATIONS COMMISSION**

2-5-1: COMMUNITY RELATIONS COMMISSION

There is hereby established a community relations commission, which shall consist of seven members, each appointed by the village president, with the advice and consent of the board of trustees. One member will be appointed by the village president to serve as chair, with the advice and consent of the board of trustees. The terms of such members shall be for three (3) years, but the initial terms shall be staggered in order that the terms of no more than three (3) persons shall expire in any one year. The

The village president may appoint a village trustee liaison. The liaison will not count towards the quorum of the commission and is not a voting member.

2-5-2: QUORUM:

Four (4) members of the community relations commission shall constitute a quorum.

2-5-3: DUTIES:


The duties of the commission shall be to aid in the dissemination of information to the citizens of the village and to develop and recommend programs for community involvement in the activities and events of the village."

Section 3. This Ordinance shall be in full force and effect from after its passage, approval, and publication in the manner provided by law.


