

**AN ORDINANCE AMENDING ORDINANCE NO. O-18-13
IMPOSING A TEMPORARY VEHICLE WEIGHT LIMIT
ON A PORTION OF McDONALD ROAD BY MODIFYING
THE DATE UPON WHICH VIOLATIONS OF THE ORDINANCE
WILL BE ENFORCED**

WHEREAS, the Village of Campton Hills, County of Kane, State of Illinois, on July 17, 2018, adopted AN ORDINANCE IMPOSING A TEMPORARY VEHICLE WEIGHT LIMIT ON A PORTION OF McDONALD ROAD; and

WHEREAS, that Ordinance in Section 2 indicated that the Ordinance would be in effect for a period of 90 days “from the effective date of this Ordinance; “ and

WHEREAS, as a practical matter, the enforcement of the Ordinance should not and cannot take effect until signs are posted; and

WHEREAS, in light of the current condition of the road and damages that would be incurred on the road if the weight limits are not in effect, the Corporate Authorities wish to have these limits in effect and enforceable for a full period of 90 days which will require a change in the time when the 90 days will begin; and

WHEREAS, the Village Police and other persons authorized to enforce the Ordinance, may, but are not required to, provide for a period of up to seven days during which warning tickets and notices of the weight limitations may be utilized rather than the issuance of complaints resulting in court hearings and where the violation is proven, penalties; and

WHEREAS, the Code of the Village of Campton Hills contains provisions which specify the penalties which are to be imposed by Ordinance violations where there is no specific penalty included within the Ordinance and which would apply here.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. The above recitals are incorporated into this Ordinance by reference.

Section 2. The effective date of the enforcement of weight limitations contained within Ordinance O-18-13 and the 90-day period of effectiveness are modified in that the effective date of the Ordinance shall be the date upon which signs are posted notifying users of McDonald Road of the existence of the 90-day weight limitations. With the exception of that amendment, all of the terms and conditions of Ordinance O-18-13 shall continue in full force and effect.

Section 3. This Ordinance shall be in full force and effect after its passage, approval and publication in the manner provided by law.


