

**AN ORDINANCE
AUTHORIZING THE DISPOSAL OF SURPLUS PROPERTY
IN POSSESSION OF THE VILLAGE OF CAMPTON HILLS**

WHEREAS, the Village of Campton Hills is in possession of the property described in words and figures in section 2; and

WHEREAS, said property is no longer necessary or useful to the Village of Campton Hills or is it in the best interest of the Village of Campton Hills that the property not be retained; and

WHEREAS, the disposal and sale of personal property is authorized by 65 ILCS 5/11-76-4; and

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. The recitals listed above are incorporated into this Ordinance as if fully set forth in Section 1.

Section 2. Pursuant to its authority under section 11-76-4 of the Illinois Municipal Code, 65 ILCS 5/11-76-4, the President and Board of Trustees find that the personal property described in Exhibit A, now owned by the Village, is no longer necessary or useful and that the Village's best interests will be served by the sale or disposal of such Property. Therefore, the Property shall be sold or disposed of in the manner that the Village Administrator deems to be in the Village's best interests.

Section 3. This Ordinance shall be in full force and effect upon its passage and approval and publication as provided by law. This ordinance shall be published in pamphlet form.


