

**AN ORDINANCE IMPOSING A TEMPORARY VEHICLE WEIGHT LIMIT
ON A PORTION OF MCDONALD ROAD**

WHEREAS, the Village of Campton Hills, County of Kane, State of Illinois has the authority to adopt ordinances and to promulgate rules and regulations that pertain to its government and affairs, including the regulation of traffic; and

WHEREAS, pursuant to 625 ILCS 5/15-316, the Village has the authority, in its discretion, to impose restrictions on the weight of vehicles operated on roads within the Village’s jurisdiction for a period not to exceed 90 days in any one calendar year; and

WHEREAS, the Village Engineer has studied that portion of McDonald Road located at west lot line for 39W680 McDonald Road to the east lot line of 38W786 McDonald Road and within the Village’s jurisdiction and has advised the Village that the road will be seriously damaged or destroyed unless the permissible weight of vehicles using this road is temporarily reduced; and

WHEREAS, based on the Village Engineer’s recommendation, the Village Board of Trustees has determined that it is in the best interest of the Village that a weight limit be imposed on vehicle use of this portion of McDonald Road for a period of 90 days from the effective date of this Ordinance.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. The above recitals are incorporated into this Ordinance by reference.


Section 2. The Village President and Board of Trustees hereby find and determine that the weight of vehicles permitted to use that portion of McDonald Road located at west lot line for 39W680 McDonald Road to the east lot line of 38W786 McDonald Road will be restricted to 28,000 pounds GVW for a period of 90 days from the effective date of this Ordinance, and hereby authorize the Village Administrator or designee to take all actions necessary to effect the vehicle weight restriction authorized by this Ordinance, including posting necessary signage.

Section 3. This Ordinance shall be in full force and effect from after its passage, approval, and publication in the manner provided by law.


