

ORDINANCE NO. O-23-12

AN ORDINANCE AMENDING SECTION 7-4-1 OF THE VILLAGE CODE OF CAMPTON HILLS, KANE COUNTY, ILLINOIS, REGARDING THE STOPPING, STANDING OR PARKING OF VEHICLES ON SIDEWALKS AND PARKWAYS

WHEREAS, the Village of Campton Hills, Kane County, Illinois (the "*Village*") is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Village President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois (the "*Corporate Authorities*") may from time to time amend the text of the Village Code of Campton Hills (the "*Code*") when it is determined to be in the best interests of the health, safety and welfare of the Village and its residents; and

WHEREAS, the Corporate Authorities are charged with the responsibility of regulating parking and traffic requirements within the Village; and

WHEREAS, periodically these parking requirements need to be adjusted to accommodate the changing needs of the Village and its residents; and

WHEREAS, the Corporate Authorities find that it is in the best interest of the health, safety, and welfare of the residents of the Village to amend the Village Code to provide for the regulations herein specified.

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. That the above recitals and legislative findings are found to be true and correct and are hereby incorporated herein and made a part hereof, as if fully set forth in their entirety.

Section 2. Section 7-4-1 ("*Stopping, Standing or Parking Prohibited*") of Chapter 4 ("*Parking Regulations*") of Title 7 ("*Motor Vehicles and Traffic*") of the Village Code of Campton Hills, Illinois, is hereby amended by deleting the following stricken language and adding the underlined language to read, as follows:

7-4-1: STOPPING, STANDING OR PARKING PROHIBITED:

- A. It shall be unlawful at all times to stop, stand or park a vehicle in any of the following places:

2. On any parkway or on or across any sidewalk from March 1 through November 30 between the hours of seven o'clock (7:00) A.M. and nine o'clock (9:00) P.M. on Monday through Friday. or between the hours of nine o'clock (9:00) A.M. and nine o'clock (9:00) P.M. on Saturday and Sunday ~~except during or within twenty-four (24) hours after a snowfall specified under section 7-4-2 of this chapter, and then only upon the driveway of a residential premises, or on any crosswalk, parkway or tree bank.~~

Section 3. All other provisions of Chapter 4 ("*Parking Regulations*") of Title 7 ("*Motor Vehicles and Traffic*") not modified herein, shall remain in full force and effect.

Section 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any other provision of this Ordinance.

Section 5. All ordinances, resolutions, motions or orders in conflict with this Ordinance are hereby repealed to the extent of such conflict.

Section 6. This Ordinance shall be in full force and effect upon its passage, approval, and publication in the manner provided by law.
