

VILLAGE OF CAMPTON HILLS  
RESOLUTION  
PROVIDING FOR A REFERENDA QUESTION AT THE  
APRIL 5, 2011 CONSOLIDATED ELECTION  
RELATIVE TO PURCHASE OF ENERGY IN BULK FOR RESIDENTS

**WHEREAS**, Illinois law now allows municipalities to aggregate accounts of residents and small business retailers and submit them as bids for the purchase of electricity on behalf of such residents and small retailers; and

**WHEREAS**, currently the Village of Campton Hills customers of utility companies receive their electric power as individual customers from utility companies such as Commonwealth Edison company; and

**WHEREAS**, it is estimated that by purchasing energy in bulk on behalf of residents and small business owners there may be cost savings of approximately ten per cent (10%) compared to present prices:

**NOW THEREFORE BE IT RESOLVED** by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

**Section 1.** The following advisory public question shall be submitted to the voters of this Village at the Consolidated Election to be held on April 5, 2011, in strict compliance with the Election Code of the State of Illinois (10 ILCS 5/28-1 et. seq. and 10 ILCS 5/16-7):

**Question**

Shall the Corporate Authorities of the Village of Campton Hills investigate arrangements for the purchase of electricity in bulk on behalf of the residents and small retailers of the Village, passing on to such residents and small retailers savings as the result of said arrangements?

**Section 2.** The Election authority for the Village of Campton Hills shall take or cause to be taken, all appropriate steps relative to the preparation of the ballots, publication of notice and all other steps as are required and appropriate pursuant to the Election Code of the State of Illinois.

**Section 3.** This Resolution shall be in full force and effect from and after its passage and approval pursuant to law.


