

**VILLAGE OF CAMPTON HILLS
RESOLUTION
RELATIVE TO PROVIDING FOR A REFERENDUM QUESTION
AT THE APRIL 5, 2011 CONSOLIDATED ELECTION**

WHEREAS, the Village of Campton Hills has authority pursuant to the Illinois Compiled Statutes in matters involving fire protection and emergency medical services; and

WHEREAS, the Fox River and Countryside Fire/Rescue District (previously known as the St. Charles Countryside Fire Protection District prior to January 1, 2011) ("FPD") now provides fire protection, fire suppression and emergency medical services to approximately fifty percent (50%) of the area of the Village of Campton Hills; and

WHEREAS, the Trustees of the FPD have announced that they will terminate their existing agreement with the City of St. Charles for fire protection and fire suppression services; and

WHEREAS, the Trustees of the FPD have announced that they will terminate their existing agreement with Tri-City Ambulance Service for emergency medical services; and

WHEREAS, the Board of Trustees of the Village of Campton Hills seeks the guidance of the voters of the Village as to what actions, if any, should be taken by the Village relative to fire suppression / fire protection issues and relative to emergency medical services issues:

NOW THEREFORE BE IT RESOLVED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

Section 1. The following public question shall be submitted to the voters of this Village at the Consolidated Election to be held on April 5, 2011, such question to be

submitted in strict compliance with the Election Code of the State of Illinois (10 ILCS 5/28-1 et. seq. and 10 ILCS 5/16-7):

A. Question No. 1

Shall the Village of Campton Hills investigate the establishment of Yes
 its own Fire and Emergency Services Department covering
 the entire Village? No


Section 2. The Election authority for the Village of Campton Hills shall take or cause to be taken, all appropriate steps relative to the preparation of the ballots, publication of notice and all other steps as are required and appropriate pursuant to the Election Code of the State of Illinois.

Section 3. This Resolution shall be in full force and effect from and after its passage and approval pursuant to law.
