

VILLAGE OF CAMPTON HILLS

RESOLUTION
RELATIVE TO PROVIDING FOR A BINDING REFERENDUM QUESTION
AT THE NOVEMBER 6, 2012 ELECTION RELATIVE TO APPOINTMENT OF THE
VILLAGE CLERK PURSUANT TO ORDINANCE
OF THE VILLAGE CORPORATE AUTHORITIES

WHEREAS, the Constitution of the State of Illinois (Article VII, Section 7) provides:

"Counties and municipalities which are not home rule units shall have only powers granted to them by law and the powers. . . (3) in the case of municipalities, to provide by referendum for their officers, manner of selection and terms of office;"

WHEREAS, the Village Clerk of the Village of Campton Hills is now elected; and

WHEREAS, the Corporate Authorities have determined that it would be in the best interest of the Village and the citizens that the Village Clerk be appointed effective May 1, 2015 pursuant to Ordinances adopted by the Corporate Authorities; and

NOW THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois that:

Section 1. The following binding public question shall be submitted to the voters of this Village at the General Election to be held on November 6, 2012, such question to be submitted in strict compliance with the Election Code of the State of Illinois (10 ILCS 5/28-1 et. seq. and 10 ILCS 5/16-7):

A. **Question No. 1**

Shall the Village Clerk of the Village of Campton Hills be appointed effective May 1, 2015 in accordance with ordinances adopted by the Corporate Authorities of the Village, rather than elected?

Section 2. The Election authority for the Village of Campton Hills shall take or cause to be taken, all appropriate steps relative to the preparation of the ballots, publication of notice and all other steps as are required and appropriate pursuant to the Election Code of the State of Illinois.

Section 3. This Resolution shall be in full force and effect from and after its passage and approval pursuant to law.
