

**A RESOLUTION
AMENDING THE NUMBER OF AUTHORIZED LIQUOR LICENSES**

WHEREAS, Section 3-1-5H of the Village Code of the Village of Campton Hills provides that the Village Board, by resolution, shall establish the number of liquor licenses to be granted within the Village, and

SECTION 1: In lieu of the number of liquor licenses previously authorized for the classes of licenses set forth herein, there shall be available for issuance by the Liquor Control Commissioner of the Village the following:

- One (1) AB&W (Beer and Wine Package Sales)
- Six (6) AR (Restaurants)
- Four (4) P (Outside Service)
- One (1) R (Bring Your Own Bottle)

SECTION 2. This Resolution shall be in full force and effect upon its passage and approval pursuant to law.
