

**A RESOLUTION AUTHORIZING AND RATIFYING THE PURCHASE
OF A 2023 DODGE DURANGO FOR THE CAMPTON HILLS POLICE
DEPARTMENT**

WHEREAS, the Village of Campton Hills, Kane County, Illinois (the “*Village*”) is a duly organized and existing municipal corporation created under the provisions of the laws of the State of Illinois and under the provisions of the Illinois Municipal Code, as from time to time supplemented and amended; and

WHEREAS, the Village operates a municipal Police Department, which is in need of a replacement squad car, the purchase of which was included as part of the Village’s Fiscal Year 2023 Budget; and

WHEREAS, the Police Chief of the Village obtained a quote for the purchase of 2023 Dodge Durango from LaPorte Chrysler Inc. (the “*Police Vehicle*”) and, due to ongoing supply chain issues, ordered the Police Vehicle. The purchase order is attached hereto and made a part hereof as Exhibit A (the “*Purchase Order*”); and

WHEREAS, the Village President and Board of Trustees of the Village of Campton Hills (the “*Corporate Authorities*”) deem it advisable and in the best interest of the health, safety, and welfare of the residents of the Village to waive bidding requirements and authorize and ratify the purchase the Police Vehicle for use by the Campton Hills Police Department.

THEREFORE, BE IT RESOLVED by the President and Board of Trustees of the Village of Campton Hills, Kane County, Illinois, as follows:

Section 1. Recitals. The recitals set forth above are hereby incorporated into and made a part of this Resolution as though set forth in their entirety.

Section 2. Approval. The Corporate Authorities hereby authorize and ratify the purchase of a 2023 Dodge Durango for the Campton Hills Police Department from LaPorte Chrysler, Inc., for an amount not to exceed \$43,145.

Section 3. Authorization. The Village Administrator is hereby authorized to execute any and all documents and take any actions necessary to implement the purchase of the Police Vehicle.

Section 4. Severability. If any section, paragraph, clause or provision of this Resolution shall be held invalid, the invalidity thereof shall not affect any other provision of this Resolution.


Section 5. Conflicts. All ordinances, resolutions, motions or orders in conflict with this Resolution are hereby repealed to the extent of such conflict.

Section 6. Effective Date. This Resolution shall be in full force and effect immediately upon its passage in order to quickly obtain the Police Vehicle for use by the Village and thereby ensure the health, safety and welfare of the residents of the Village.
